BAC RESOLUTION NO. 08D, S. 2026

A RESOLUTION CORRECTING THE TIME OF THE PRE-BID CONFERENCE FOR THE PROJECT “BASIC EDUCATION FACILITIES FUND (BEFF) 2026 – LEARNING CONTINUITY SPACES” CONDUCTED ON MAY 7, 2026, AS POSTED IN THE GPPB WEBSITE

WHEREAS, the Bids and Awards Committee (BAC) of the Schools Division Office of Camarines Norte conducted the Pre-Bid Conference for the project entitled “BASIC EDUCATION FACILITIES FUND (BEFF) 2026 – LEARNING CONTINUITY SPACES – LOTS 3–4” on May 7, 2026 at the BAC Office, Schools Division Office Conference Hall, Daet, Camarines Norte;

WHEREAS, the actual and official time of the conduct of the said Pre-Bid Conference was at 9:00 o'clock in the morning (9:00 A.M.), as evidenced by the Attendance Sheet, Minutes of the Pre-Bid Conference, BAC records, and actual proceedings conducted by the BAC and attended by the prospective bidders;

WHEREAS, it was discovered that the time reflected in the posting in the Government Procurement Policy Board (GPPB) website/PhilGEPS posting was erroneously entered as 1:00 A.M. instead of 9:00 A.M.;

WHEREAS, the incorrect entry of “1:00 A.M.” was purely an inadvertent clerical and encoding error, committed unintentionally and without malice, fraud, bad faith, or intent to mislead any prospective bidder or interested party;

WHEREAS, despite the erroneous posting, the actual Pre-Bid Conference was conducted openly, transparently, and in accordance with the provisions of Republic Act No. 12009 and its Implementing Rules and Regulations (IRR), with the attendance and participation of the prospective bidders and concerned officials;

WHEREAS, the correction of the posting is necessary to ensure that the procurement records accurately reflect the true and actual proceedings of the BAC and to maintain the integrity, transparency, and consistency of the procurement documents and records;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby **RESOLVED**, that the Bids and Awards Committee (BAC) of the Schools Division Office of Camarines Norte hereby:

1. **CORRECTS** the time of the Pre-Bid Conference conducted on May 7, 2026 for the project "BASIC EDUCATION FACILITIES FUND (BEFF) 2026 – LEARNING CONTINUITY SPACES – LOTS 3–4" from 1:00 A.M. to 9:00 A.M.;
2. **DECLARES** that the erroneous posting of "1:00 A.M." in the GPPB website/PhilGEPS posting was due solely to an unintentional clerical and encoding error;
3. **AFFIRMS** that the actual conduct of the Pre-Bid Conference took place at 9:00 A.M. on May 7, 2026, with the attendance of the BAC, TWG, BAC Secretariat, Observers, and Prospective Bidders;
4. **DIRECTS** the BAC Secretariat to undertake the necessary corrective measures and annotations in the procurement records and related documents to reflect the correct time of the Pre-Bid Conference; and
5. **FURTHER DIRECTS** that this Resolution form part of the official procurement records of the project for reference and documentation purposes.
