Invitation to Bid for Basic Education Facilities Fund (BEFF) 2026 – Learning Continuity Spaces – Lot 5 to Lot 9

- 1) The Department of Education (DepEd) Division of Camarines Norte, through the 2026 Government Appropriations Act (GAA) intends to apply the sum of Twenty-One Million Four Hundred Sixty-Eight Thousand and Six Hundred Pesos (₱ 21,468,600) being the Approved Budget for the Contract (ABC) to payments under the contract for Learning Continuity Spaces (LCS). Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2) The Department of Education (DepEd) Division of Camarines Norte now invites bids for the above Procurement Project. Completion of the Works is required within thirty (30) calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4) Interested bidders may obtain further information from *BAC Office, Administrative Building, DepEd-Schools Division Office, Division of Camarines Norte, F. Pimentel Ave., Barangay II, Daet, Camarines Norte* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5) A complete set of Bidding Documents may be acquired by interested bidders on *May 8, 2026 to May 20, 2026 before nine o'clock in the morning (9:00 AM)* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (₱ 5,000.00) per Lot.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The *DepED Division of Camarines Norte* will hold a Pre-Bid Conference on *nine o'clock in the morning (9:00 AM) on May 8, 2026 at Division Office Conference Hall, DepEd-Schools Division Office, Division of Camarines Norte, F. Pimentel Ave., Barangay II, Daet, Camarines Norte*, and/or through video conferencing via *MS Teams in the following detail: <https://bit.ly/42nBnTo>*, which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before *May 20, 2026, nine o'clock in the morning (9:00 AM)*. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9) Bid opening shall be on *May 20, 2026, nine o'clock in the morning (9:00 AM) at Division Office Conference Hall, DepEd-Schools Division Office, Division of Camarines Norte, F. Pimentel Ave., Barangay II, Daet, Camarines Norte* and/or via *videoconferencing using MS Teams in the following detail: <https://bit.ly/48jrvO3>*. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) *Bidder's representative must present notarized Special Power of Attorney (SPA) and any valid ID.*
- 11) The *DepEd-Division of Camarines Norte* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
